Our challenges and aims in the near future are strictly interconnected.

First, we aim to promote interdisciplinarity and multidisciplinary: this includes sociology, anthropology, history, biblical studies, philosophy, legal studies or psychology, but also feminist studies, digital studies, political sciences, social movement studies. etc. We would also like to encourage the community to tackle the challenging issues that surround the study of religion in contemporary Europe, including, for example, nonreligion, and the role of religion in politics.

Second, we want to foster inclusion and solidarity by welcoming contributions by scholars at all stages of their careers and from different parts of the world.

Finally, the journal's scope is on religion and Europe: both terms are challenged, transformed and changed, in a constant work of boundaries, negotiations and social construction. Hence, we are seeking contributions that address religion in any of its multiple manifestations, be they traditional forms and less obvious ones. Geographically, the focus is on Europe. Therefore, we welcome manuscripts that focus on this region, those that study influences and interconnections between Europe and other regions of the world, and those that reflect upon the boundaries and meanings of Europe.

- In 2022, the Church of the Flying Spaghetti Monster had its application for state recognition rejected after a much prolonged and difficult process. While they originally applied in December 2017 – immediately after the enactment of the current law on religious communities outside the Church of Denmark – they had waited almost five years for the rejection. During this time the so called Advisory Committee on Religious Communities had dealt with the application several times. Information from the process thus shows that in 2019 the committee had recommended the Church of the Flying Spaghetti Monster, but for unknown reason shortly after the committee retracted its recommendation in order to reconsider. In documents from June and October 2020 the committee cites the nature of caricature of the Church of the Flying Spaghetti Monster and that it should not be considered for recognition. The effect of this is that the church cannot conduct marriage with legal validity and are restricted from certain tax benefits, but are still free to practice and organize, as per the Danish Constitution article 67.

A revision of the Act on religious communities has been postponed to the parliamentary year of 2023/24. In 2023, the Ministry of Ecclesiastical Affairs received harsh criticism from [Rigsrevisionen](#) (Office of the Auditor General) for their administration of the Danish Register of Religious Communities.

This is according to the results of an online survey conducted by the NMS Market Research Slovakia agency, with 61 percent of Slovaks surveyed agreeing with this option. Less than one-fifth of the population considers the current model of financing churches and religious communities from the state budget to be the most appropriate. The separation of the church and the state is supported mainly by men (66 percent), older people aged 65 and over (71 percent), people with secondary (64 percent) and higher education (71 percent), and people living in Bratislava (70 percent). The opposite opinion was expressed by 26 per cent of respondents who disagree with the separation of church and state, 13 per cent do not know or do not want to comment on this topic.

Décisions Juridiques / Legal Decisions

- *Beaudoin v. British Columbia (Attorney General)*, 2022 BCAA 427—Leaders of three churches submitted that previous Covid-19 public health orders which restricted in-person religious services violated their constitutional rights, including the rights to freedom of religion and freedom of peaceful assembly. The court concluded that restrictions on such rights were reasonably and proportionately balanced with provincial public health objectives. The court dismissed their appeal.
- *Del Grande v. Toronto Catholic District School Board*, 2023 ONSC 349—The applicant, a trustee of a Catholic school board, sought judicial review of four decisions that concluded he breached the code of conduct for trustees, which were followed by sanctions and confirmations of those decisions. The breach occurred when the applicant made inflammatory and disrespectful comments during a board meeting on including gender identity, gender expression, family status and marital status as protected grounds in the school board’s code of conduct. The court dismissed the application.
- *Ontario (Attorney General) v. Trinity Bible Chapel*, 2023 ONCA 134—Two churches and their members appealed a 2022 decision that Covid-19 public health restrictions on religious gatherings, which infringed upon their religious freedom, were justified when weighed against public health measures. The court dismissed their appeal.
- *R. v. Koopman*, 2022 BCPC 249—Pastor John Koopman was found guilty of hosting a worship service in breach of a provincial Covid-19 public health order in December 2020. The conviction was not entered, however, as Pastor Koopman filed a notice of intent to challenge the constitutionality of the legislation that made the gathering illegal.
- *Servatius v. Alberni School District No. 70*, 2022 BCCA 421—The appellant, an evangelical Christian, appealed a 2020 decision that demonstrations of Indigenous practice at her children’s elementary school did not infringe upon her right to religious freedom or the duty of state neutrality. These practices were a smudging demonstration in classrooms and a prayer that was said by a hoop dancer at a school assembly. The court dismissed the appeal and ruled that the appellant must repay the school district’s legal costs.
