- Vienna Mayor Ludwig launches "[Religious Council](#)"
A "Religious Council" is to be set up in Vienna. This was announced by Mayor Michael Ludwig (SPÖ) after a meeting with representatives of the religious communities. The new institution will be based at the Mayor's office. According to Ludwig, the "Religious Council", in which all recognised religious denominations will be represented, will meet at least twice a year and serve to discuss current developments and problems.
- [Neutral State? Interdisciplinary Perspectives on the Autonomy of Religion, Art and Science.](#)
From June 19 to 20 the conference "Neutral State Interdisciplinary Perspectives on the Autonomy of Religion, Art and Science?" organized by the research cluster "Transformations

of Law in Religion and Society" of the Research Centre RaT took place. The aim of the event, which was organized under the direction of Prof. Stefan Hammer (Department of Legal Philosophy) and Prof. Andreas Kowatsch (Department of Canon Law and Law on Religion), was to bring experts from the three fields into conversation with each other and to offer an insight into current debates and problems. From the many knowledgeable contributions and the lively discussion, two points in particular emerged as decisive: First, under the current legal and social conditions, scepticism about the possibilities of religious-ideological neutrality of the state is necessary. Second, there is a crisis in the claim to autonomy of the various fields, but especially of science: Self-determination is visibly coming under pressure under the increasing economic-political dependencies. This shows how important it is to critically question the concepts of autonomy and neutrality again and again.

The Jehovah's Witnesses have been present in Austria for 100 years now and have been officially recognised as a religious community since 2009. Board member Johann Zimmermann would welcome improvements in the culture of remembrance. For example, he suggested a memorial for the so-called "Bible Students" who were persecuted during the National Socialist regime.

The group aims to make visible the research on law and religion at UCPH, identify research needs, encourage research cooperation, and explore new and viable research projects, which will contribute to developing law and religion as an interdisciplinary and cross-faculty focus.

Actualités juridiques / *Legal news*

- In autumn 2023, the Danish government presented a bill to ‘ban Quran-burning’. Following months and years of increasing attention to both politically motivated burnings and ‘dismantling’ of the Quran in both Denmark and Sweden, international political pressure has been put on Denmark to limit this. The bill will amend the criminal code to criminalize ‘improper treatment of a text with significant religious significance for a religious community’. The proposal has generated much debate and is seen by many as a re-emergence of a blasphemy ban, which was lifted in 2017. Danish parliament is expected to vote for the bill in the 2023-24 session, but it is expected to pass as the government currently constitutes a majority.
- Two important anniversaries are being marked in 2023. One of these events is the 50 years of free abortion in Denmark. Following the debates sparked by this, the Ethical council, an independent council which offers advice to the Parliament and assesses ethical issues for the government decided in September 2023 to change their recommendation of a general limit on abortions from 12 weeks to 18 weeks. The other big anniversary is the 75 years of female ministry in Denmark, which was introduced – some would say enforced on - the Evangelical-Lutheran Church in Denmark in 1948. Today there is little resistance left but an exemption from general laws on gender equality exists for employment within the church even if the pastors are state employees. The abolition of this exemption is currently being discussed.
- A revision of the Act on religious communities has been postponed for the third time. Changes to the law are expected to be presented for the parliamentary in the parliamentary year of 2024/25.

- **Corte di Cassazione, civ., 10/07/2023, n. 19502 - CHANGE OF RELIGION – REASON FOR THE SEPARATION** The change in religious faith and the consequent participation in the collective practices of the new cult, taking the form of an exercise of the rights guaranteed by the art. 19 of the Constitution, cannot in themselves be considered as a reason for the separation, unless adherence to the new religious belief translates into behavior incompatible with the concurrent duties of a spouse envisaged by the art. 143 of the Civil Code, thus determining a situation where cohabitation cannot continue
- **Corte di Cassazione, civ., 30/05/2023, n. 15142 – EXEQUATUR - NULLITY OF THE MARRIAGE BY THE ECCLESIASTICAL JUDGE**
In the event of a "*pro futuro*" condition being added to the marital bond, pursuant to art. 1102, par. 1, of the canon code (in this case consisting in the greater "*post nuptias*" affection of the other spouse), the enforceability of the ecclesiastical sentence declaring the nullity of the concordat marriage postulates that the condition has been manifested to the other spouse, or has been these known or not culpably ignored; otherwise, the resolution is prevented by contrary to Italian public order, within which the fundamental principle of protection of good faith and custody of the innocent spouse must be included.
- **Corte di Cassazione, civ., 07/03/2023, n. 6802 - CONFLICT BETWEEN SEPARATED PARENTS IN CHOICES RELATING TO THE MINOR - RELIGIOUS EDUCATION**
In the event of a conflict between separated parents regarding issues of greater interest to their minor children, the relevant decision is left to the judge pursuant to art. 337 ter, paragraph 3, of the Civil Code, which must take into account exclusively the superior moral and material interests of the minor involved, the identification of which involves his necessary hearing in all those cases in which the comparison with the latter can offer suitable elements to understand what are the most appropriate measures to adopt in your interest.
- **Corte di Cassazione, civ., 16/01/2023, n. 1164 – IRPEG - ECCLESIASTICAL BODIES WITH THE PURPOSE OF RELIGION OR WORSHIP**
The relief referred to in art. 6, paragraph 1, Presidential Decree. n. 601 of 1973 applies to bodies with charitable or educational purposes or equivalent to them (such as ecclesiastical bodies with the purpose of religion or worship) and for non-commercial (or non-prevalent commercial) activities in a relationship of direct and immediate instrumentality with the aforementioned purposes, i.e. aimed at procuring the economic means necessary for the institutional purpose of the entity and compatible with this in nature and relevance, instead having to exclude the coherence of those activities that can be used indifferently for the pursuit of any other purpose and aimed at the mere procurement of economic benefits, even if used for institutional purposes. (In this case, the SC ruled out that the activity of leasing out properties - carried out by the diocesan institute for the support of the clergy and aimed at producing income to integrate the remuneration due to the priests - constitutes a commercial activity instrumental to the purposes of religion or cult).
- **Corte di Cassazione, civ., 13/01/2023, n. 838 - EXEQUATUR - NULLITY OF THE MARRIAGE BY THE ECCLESIASTICAL JUDGE - JUDGMENT BROUGHT BY ONLY ONE OF THE SPOUSES**
The judgment of exequatur of the sentence of nullity of the marriage pronounced by the ecclesiastical court, promoted by only one of the spouses, is an ordinary judgment of cognition, to which the articles apply. 796 and 797 c.p.c., therefore the sentence pronounced to settle the proceedings is null and void, due to violation of the right of defense and the principle of adversarial proceedings, without the terms provided for by the art being granted. 190 c.p.c.
- **Corte di Cassazione, civ., 04/01/2023, n. 149 - EXEQUATUR - NULLITY OF THE MARRIAGE BY THE ECCLESIASTICAL JUDGE - LIVING TOGETHER AS SPOUSES - MENTAL VICE**
In terms of exequatur of ecclesiastical sentences, cohabitation "as spouses" - although constituting an essential element of the "marriage-relationship" where it lasts for at least three years from the celebration and integrating a legal situation of "Italian public order" - is not an obstacle to the declaration of effectiveness of the ecclesiastical sentence of nullity due to genetic

defects of the "marriage-deed" which are in turn protected by nullity in the Italian legal system; in particular, this limit does not apply with respect to the exequatur of the ecclesiastical sentence of nullity for a mental defect that makes one incapable of contracting marriage, corresponding to that also provided for in the Italian legal system by art. 120 civil code.

- **T.A.R. Firenze, (Toscana) sez. IV, 28/07/2023, n.792 - CATHOLIC RELIGION LESSONS**
The regulatory system provides for the right to choose whether or not to attend Catholic religion lessons in schools of all levels, other than universities. The fullness and freedom of this option is essential in order to guarantee the effectiveness of the person's religious freedom, constitutionally protected and safeguarded, both for individuals and in social groups (including schools) where they carry out their personality. This freedom of choice cannot therefore be subject to any limit, not even imposed by provisions or circulars of the Ministry or of the individual educational institution, because it would damage the religious freedom of the student who can opt for exemption even during the year, and not only at the time of online registration (in particular the request of the parents of a student who had attended religion class during the first 4 years of primary school and who had had their choice of no longer attending religion class rejected during the fifth year).

Décisions Juridiques / Legal Decisions

- *Ewert v. Canada*, 2023 FC 1054—An Indigenous inmate claimed that Correctional Services Canada violated his right to freedom of religion under the *Canadian Charter of Rights and Freedoms* when they searched his sacred medicine bundle, and when they requested that he remove his headbands, which are also spiritually significant, for photographs and searches. The court concluded that the search did violate his religious freedom, but based on the evidence, the demands to remove his headbands did not.
- *Muslim Association of Canada v. Attorney General of Canada*, 2023 ONSC 5171—The Muslim Association of Canada (MAC) challenged the decision of the Canada Revenue Agency to conduct an audit of the MAC and suspend its charitable status, due to unverified links to terrorism. The MAC argued in part that these decisions are based on discriminatory beliefs, and that they violate its *Charter* right to freedom of religion. The court dismissed the MAC's application on the grounds of prematurity.
- *Wiring v. Law Society of Alberta*, 2023 ABKB 580—The complainant of this case, an amritdhari Sikh, argued that the Oath of Allegiance to the Queen, which he must take to practice law in the province of Alberta, violates his *Charter* right to freedom of religion. He stated that his religion requires an absolute oath of allegiance to the divine being of Sikhism. The court concluded that the required oath is symbolic, not literal, and therefore it does not interfere with his religious freedom.
